Friday, October 9, 2026	Last day to drop without academic penalty for 15-week Part of Term (drop with W/WX, not WF). Subject to the Course Withdrawal Policy as stated in the <i>Undergraduate Bulletin</i> .
Tuesday, October 20, 2026	Last day to add or drop classes for Second Half Semester (POT B) . See Parts of Term calendar for all registration deadlines.
